I am refer to your online application even number dated **10-09-2019** seeking grant of registration for your Association under Foreign Contribution (Regulation) Act. 2010.

2. Your request has been carefully considered by the Central Government but it is regretted that the same cannot be agreed to, as it has been found that:

3. **On enquiry and examination thereof, the case attracts Section 12(2) of FCRA 2010. Adhering to the Natural Justice, enough opportunities of being heard were given to you for clarification but you have not availed any of them. Accordingly, the Competent Authority has refused the application of the association seeking Renewal/Registration/Prior Permission under FCRA 2010. It is mentioned that receipt of Foreign Contribution without valid permission from MHA is a serious violation of FCRA 2010 and may attract appropriate penal action if found.**

In terms of rule 9(3) of the Foreign Contribution (Regulation) Rules, 2011, you may, if you so desire, submit a fresh online application complete in all respects, along with all the required supporting documents only six months after submitting an application either for the grant of prior permission for the same project or for registration.
